

## ¿What can I do if I get hurt on the job?

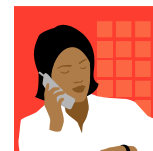


- Notify the employer immediately.
- Go immediately to the doctor and inform the doctor that the injury happened on the job and that you want to fill out the form to request benefits.
- Make sure that the insurance company received your claim.

\*If the employer or the doctor did not file the claim, then you can do it yourself.

**Usually, you must report the injury within 90 days from the date of injury.**

**NOTE:** Filing a claim does not require a social security number.
